

LET'S TALK VACCINES

A vaccine frenzy, a vaccine czar, a fearful populace, and the global chaos mounts. It is time to talk VACCINES.

Most parents consider it standard practice to have their children vaccinated. What they are not aware of, though, is that multitudes of children have been harmed as a result. What Is in a Vaccine?

Thinking people should be asking: "Seventy-two doses?! Of what?" If doctors knew the toxic cocktail they are injecting into people, they would cease and desist, and no parents would have their child vaccinated.

Aluminum

Known to cause brain damage at all doses, linked to ALZHEIMER'S DISEASE, dementia, seizures, autoimmune issues, SIDs and cancer. This toxin accumulates in the brain and causes more damage with each dose.

Formaldehyde [formalin]

Beta-Propiolactone

Glutaraldehyde

Can be incorporated into the recipient's DNA and cause unknown GENETIC MUTATIONS. This also includes eggs, dairy; this leads to allergies.

Latex Rubber

Can cause life-threatening allergic reactions

Human and Animal Cells

Human DNA FROM ABORTED BABIES. Pig blood, horse blood, rabbit brains, dog kidneys, cow hearts, monkey kidneys, chick embryos, calf serum, sheep blood and more. Linked to childhood leukemia and diabetes.

Mercury [thimerosal]

One of the most toxic substances known. If even a thermometer breaks, the building is cleared and HAZMAT is called. Tiny doses cause damage to the brain, gut, liver, bone marrow, nervous system and/or kidneys. Linked to autoimmune disorders and neurological disorders like AUTISM.

Monosodium Glutamate [MSG]

A toxic chemical that is linked to birth defects, developmental delays and infertility. Banned in Europe.

Neomycin Sulphate [antibiotic]

Interferes with vitamin B6 absorption which can lead to epilepsy and brain damage. Allergic reactions can range from mild to life-threatening.

Phenol/Phenoxyethanol [2-PE]

Used as anti-freeze. TOXIC to all cells and capable of destroying the immune system.

Polysorbate 80 & 20

Known to cause CANCER in animals and linked to numerous autoimmune issues and infertility.

Tri(n) Butylphosphate

Potentially toxic to the kidney and nervous system.

The same toxins—such as formaldehyde, mercury, and aluminum—environmentalists fight against in our water, air, and food are in vaccines, which go to the bloodstream and to the brain.

The Children's Health Report

Barbara Loe Fisher, President of *The National Vaccine Information Center* (NVIC), reported that, in 2017, the federal government said children were to receive 69 doses of 16 vaccines, from day of birth to age 18.

In the late 70s and into the 80s, children received 23 doses of 7 vaccines. That number has now tripled! In this time period of a dramatic increase of vaccinating, there has been an epidemic of chronic disease and disability:

- One child out of 6 in America is learning-disabled.
- One child in 9 has asthma.
- One in 50 has autism.
- One in 400 is developing diabetes.
- Millions more have inflammatory bowel disorders, rheumatoid arthritis, epilepsy—epilepsy is on the rise.
- 30% of young adults have now been diagnosed with having a mental illness—anxiety disorder, bi-polar disorder, schizophrenia.

Many feel that our nation is in the midst of a vaccine epidemic.



No Liability!

Just as one plus one equals two, injecting toxins into people will equal sick people.

Someone in the US government must believe this, since it has a trust fund called *The National Vaccine Injury Compensation Program* (TNVICP). But why is the government providing compensation for the vaccine-damaged rather than the companies that produce the harmful product? *Because vaccine makers are exempt from all liability!*

This is shocking, but true. What other industry is granted such immunity?

In 1986, the US Congress passed the National Childhood Vaccine Injury Act (NCVIA), granting indemnity to pharmaceutical companies for injuries resulting from childhood vaccines—“no matter how toxic the ingredients, how negligent the manufacturer or how grievous the harm.”

Monies for the government trust fund come out of the pockets of US taxpayers via an excise tax on each vaccine. Yes, taxpayers are the ones left carrying the bill! This should tell you something about the world of Pharma and its many tributaries. They pipe, and even the government starts dancing.

TNVICP has paid out over 4 billion dollars—a large amount of money for a product said to be safe by both their makers and the medical institutes promoting them. And that amount would be vastly more if the government didn’t make it so very difficult to process a claim. Some lose hope during the long battle. Many others never report the vaccine damage at all.

Another factor is that apparently most doctors are not trained to recognize vaccine damage in children.

Suppressing Information

Informed consent. Has this not long been the accepted approach to any medical decisions, and do we not have laws in place to protect those rights? Adults are capable of making choices for themselves, and who better than a parent to seek what is best for their child?

Yet, suppressing information is currently at an all time high. Information concerning any vaccine hesitancy is being either censored or vilified, even to the point of being declared harmful to society. Never mind the fact of the documented harm many have suffered due to vaccines.

Why not allow the people to weigh out the information for themselves? People are well capable of researching both sides of the debate. Someone out there seems to fear people will do just that—research.

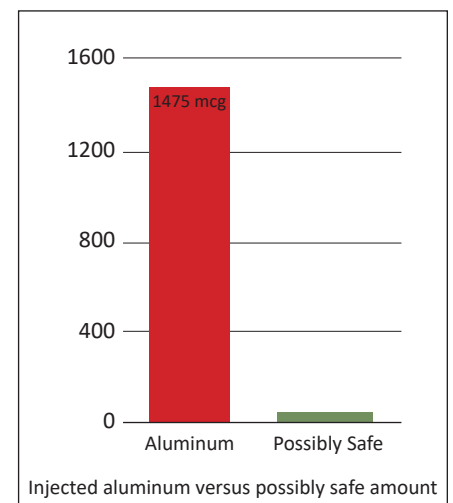
I concur with the doctor that stated: “A parent’s decision to withhold all or some vaccinations should be made from information, not coercion.”

Gates’ Destructive Vaccines

Promising to eradicate polio with \$1.2 billion, Gates took control of India’s National Advisory Board (NAB) and mandated 50 polio vaccines (up from 5) to every child before age 5. Indian doctors blame the Gates campaign for a devastating vaccine-strain polio epidemic that paralyzed 496,000 children between 2000 and 2017. In 2017, the Indian Government evicted Gates and his cronies from the NAB. Polio paralysis rates dropped precipitously. In 2017, the World Health Organization reluctantly admitted that the global polio explosion is predominantly vaccine strain, meaning it is coming from Gates’ vaccine program. The most frightening epidemics in the Congo, the Philippines, and Afghanistan are all linked to Gates’ vaccines. By 2018, 3/4 of global polio cases were from Gates’ vaccines.

In 2014, the Gates Foundation funded tests of experimental HPV vaccines, developed by GSK and Merck, on 23,000 young girls in remote Indian provinces. Approximately 1,200 suffered severe side effects, including autoimmune and fertility disorders. Seven died. Indian government investigations charged that Gates-funded researchers committed pervasive ethical violations: pressuring vulnerable village girls into the trial, bullying parents, forging consent forms, and refusing medical care to the injured girls.

In 2010, the Gates Foundation funded a trial of GSK’s experimental malaria vaccine, killing 151 African infants and causing serious adverse effects including paralysis, seizure, and febrile convulsions to 1,048 of the 5,049 children.

During Gates 2002 MenAfriVac Campaign in Sub-Saharan Africa, Gates operatives forcibly vaccinated thousands of African children against meningitis. Between 50-500 children developed paralysis. South African newspapers complained, “We are guinea pigs for drug makers.”

Nelson Mandela’s former Senior Economist, Professor Patrick Bond, describes Gates’ philanthropic practices as “ruthless” and “immoral.”

In 2010, Gates committed \$10 billion to the WHO promising to reduce population, in part, through new vaccines. A month later, Gates told a Ted Talk that new vaccines “could reduce population.” In

2014, Kenya’s Catholic Doctors Association accused the WHO of chemically sterilizing millions of unwilling Kenyan women with a phony “tetanus” vaccine campaign. Independent labs found the sterility formula in every vaccine tested.

After denying the charges, WHO finally admitted it had been developing the sterility vaccines for over a decade.

Similar accusations came from Tanzania, Nicaragua, Mexico, and the Philippines.

A 2017 study (Morgensen et al. 2017) showed that WHO’s popular DTP is killing more Africans than the disease it pretends to prevent. Vaccinated girls suffered ten times the death rate of unvaccinated children.

Gates and the WHO refused to recall the lethal vaccine which WHO forces upon millions of African children annually.

Global public health advocates around the world accuse Gates of hijacking WHO’s agenda away from the projects that are proven to curb infectious diseases—clean

water, hygiene, nutrition and economic development.

In addition to using his philanthropy to control WHO, UNICEF, GAVI and PATH, Gates funds private pharmaceutical companies that manufacture vaccines, and a massive network of pharmaceutical industry front groups that broadcast deceptive propaganda, develop fraudulent studies, conduct surveillance and psychological operations against vaccine hesitancy and use Gates’ power and money to silence dissent and coerce compliance.

In his recent nonstop Pharmmedia appearances, Gates appears gleeful that the Covid-19 crisis will give him the opportunity to force his third-world vaccine programs on American children. 📷

THE WORLD'S MOST CONTROVERSIAL VACCINE

It's been a difficult year. Life's pleasures we once took for granted vanished, seemingly overnight. Things as simple as sitting down with family at our favourite restaurant seem like a dream of times past. Liberties we once cherished were replaced by a myriad of mandates and restrictions—mask up, don't visit loved ones, stay home, cancel travel plans, shut down your business. It proved to be a year too difficult for many. Reports from around the world attest to the fact that deaths by suicide have far exceeded the mortality rate of COVID-19.

Humanity is united in the longing for the end of the alleged pandemic. Young and old are asking when children will return to school. When will travel resume? When will the restrictions on businesses end? When will we be allowed to gather again? To all these questions, the answer is repeated—once the population is vaccinated. And so, to many, the small vials containing the COVID-19 injection symbolize the key to freedom and a return to normal life.

Vaccine makers from around the world raced to develop the promised vaccine. And now, it has arrived.

But this vaccine holds very little semblance to what we have known as vaccines up until now. It is the first of its kind, using mRNA technology never before approved for human use. Scientists have yet to find answers to many questions about the vaccine. How long does the vaccine remain effective? Is it safe for children or pregnant and breastfeeding women? The trials also never tested if the vaccines will prevent transmission of the virus or if they will prevent COVID-19 deaths.

It normally takes 10-15 years for a vaccine to be developed and safety tested before approval. Yet the COVID-19 injections were

developed and authorized in less than a year! Therefore, there is nothing at all known about the long-term effects of this newest concoction.

With so many questions still needing answers, can the COVID-19 vaccine be considered anything but an experimental injection? It can't be, you say. After all, the FDA approved the vaccines. The media has certainly been busy promoting the vaccine's safety and efficacy, leaving millions under the impression that they are approved. In reality, they were only given Emergency Use Authorization (EUA). By definition, products approved for EUA are unapproved and experimental, given licence to be used in emergencies when no other adequate alternatives can be found. Let us not be fooled to think that the COVID-19 vaccines are approved and safe.

Whether it is due to this fact or because people have lost trust in the medical industry, multitudes are hesitant about these vaccines. 55% of surveyed firefighters in the New York Fire Department plan to refuse the shot. In Ohio, 60% of nursing home staff declined the vaccine. Likewise, only 50% of frontline workers in Riverside, California were willing to receive the jab. Other countries are seeing similar trends. Up to 40% of care workers in the UK plan to decline the vaccine. In France, 60% of the people do not want to be inoculated.

The widespread reluctance to get the COVID-19 vaccine has caused hospitals, companies, and officials to resort to incentives for employees to get the vaccine. Home security cameras, Google Nest entertainment systems, Aventon fixed-gear bicycles, and gift cards for Airbnb and Lyft were among the incentives offered by the Los Angeles Fire Department. McDonalds offered their employees paid time

off to get the shot. Gracedale, a Pennsylvania nursing home, offered employees \$750 to get the vaccine. Some officials at long-term care chains even gave their employees an ultimatum—get immunized or get fired.

Perhaps the most surprising to some is the vaccine hesitancy among hospital staff. After all, they assumed healthcare workers would be most knowledgeable about the science backing the vaccines. But possibly it is exactly that—*their knowledge*—that is causing their hesitation.

While many dare not raise concerns openly, the medical professionals' reluctance to receive the vaccine speaks volumes. There is also a rising number of health professionals that are speaking out. Larry Palevsky, a pediatrician based in New York, has been vocal in warning others about the dangers of these new injections. He is joined by a multitude of other highly accredited medical professionals, scientists, and experts who are trying to raise awareness about the injections. Even pro-vaccination doctors, such as Dr. Martin Feelay, have raised concerns about these vaccines. Dr. Sherri Tenpenny, in the medical profession since 1985, has warned that although we will see many cases of anaphylactic shock as a result of the vaccines, the true deadly effects will not be fully seen for many months after people start receiving them.

Notwithstanding the resources, science, and evidence brought forth from these experts, mainstream media knows but one response—censorship or vilification. The call for global immunization has gone out, and the pressure is on to respond. Anyone who refuses the vaccine is “irresponsible” and even “unethical.” Those who dare to raise concerns about the novel vaccine are censored, fired from their jobs, removed from social media, and labeled a conspiracy theorist or a spreader of “misinformation.” Never before in North America have we seen such overt and targeted censorship against anyone that does not submit to

the propagated narrative.

As of February 4 of this year, CDC's Vaccine Adverse Event Reporting System (VAERS) has reported 12,044 injuries and 653 deaths from the COVID-19 vaccines in the USA. Over 339 pages outline multitudes of reactions that frequently fol-

lowed only minutes after receiving the vaccination. When we realize that only a fraction of vaccine reactions are reported to VAERS, it is even more shocking to see the thousands of adverse reactions reported. And this, after only nine short weeks since the vaccinations began!

However, in every instance of ill-effects that surface after a vaccination, there is an immediate cry from media outlets that the death is definitely not linked to the vaccine at all. It matters not how many deaths and life-impairing injuries are taking place, the mantra that must be remembered is that the COVID-19 vaccines are safe and effective. And the hundreds that are dying shortly after receiving the experimental injection are dying of anything but the vaccine. Future generations will laugh at our absurd gullibility.

Some are trusting the assurances that the vaccines will not be made mandatory. But there are many other ways to force compliance. If the incentives offered do not yield sufficient arms to poke, there are many other ways to increase the line-ups at the vaccination sites. Deny people access to communal spaces such as movie theatres or concerts, restrict their travel and freedom to move around, refuse to admit their children into schools, block their entry to long-term care facilities, take their jobs from them, and soon you might have a lot more “volunteers” lining up.

It is absolutely monstrous to push global vaccinations using experimental injections for a viral infection with the survivability rate of 99%! By and large, the coronavirus is only seriously affecting the very elderly with pre-existing comorbidities. The risk of coronavirus to children is minute. And yet, there is real and forceful pressure for the entire world population to line up to receive these novel injections. Such an illogical response can only be attributed to the fact that men like Bill Gates—without a medical education nor a scientific back-

ground, but with millions invested in the vaccines—wield global influence and power.

Has the world entirely forgotten the Nuremberg Code in such a short time? After discovering the shocking human experiments performed during the Nazi regime, The Nuremberg Code was drafted in 1947 to protect future generations from such atrocities, and from the imposition of medical procedures without one's consent. Coercing the populace to receive novel and unapproved injections, while making it impossible for them to give full consent by censoring anything that would give full disclosure, is directly contradicting the Nuremberg Code.

WHO HEADS THE WHO?

In the early days of what would come to be called the coronavirus pandemic, the focus was on China, the country where the SARS-CoV2 virus was first detected. Facing growing alarm from countries in the West, China did what all communist countries have done when trying to save themselves from embarrassment and criticism: it downplayed facts, obfuscated, and tried to suppress the truth. But knowing that its own statements and attestations are suspect in the eyes of free nations, China realized that it needed an ally of international standing to back it up. Where better to look than to the man that it backed for one of the most prestigious positions in the world?

His name is Dr. Tedros Adhanom Ghebreyesus, but you can just call him "Dr. Tedros." The Director-General of the World Health Organization (WHO) since 2017, Tedros is the first head in the organization's 73-year history who is not an actual physician. He holds a PhD in Community Health and a Master's degree in Immunology and Infectious Diseases. He is not a medical doctor.

Prior to becoming Director-General of the WHO, Tedros served in the Ethiopian government, first as Minister of Health (2005-2012) and then as Minister of Foreign Affairs (2012-2016). Lack of medical degree aside, these qualifications are nothing to sniff at and carried a lot of weight among the African nations who also backed his election to lead the international



organization. But it is his other credentials that likely endeared him to the Chinese communist regime and made them throw the considerable weight of their support behind him.

Tedros is a member of the Tigrayan People's Liberation Front (TPLF), a far-left, powerful political party responsible for human rights abuses in Ethiopia. So many, in fact, that it is listed in the Global Terrorism Database. After the TPLF overthrew the military dictatorship in 1991, Tedros rose quickly within its ranks. Under his watch in his various positions within the government, Ethiopia has borrowed billions of dollars from China. He has also been accused of orchestrating the kidnap and arrest of dissidents and the cover-up of at least three cholera epidemics in his country.

Indebtedness and the ability to deny plausible liability in a health crisis—these two things are decidedly in China's favor, and Tedros wasted no time in paying his sponsors back at the outset of the current “pandemic.”

On January 14, 2020, the WHO tweeted, “Preliminary investigations by the Chinese authorities have found no clear evidence of human-to-human transmission of the novel #coronavirus (2019-nCoV) identified in #Wuhan, #China.” This despite the fact that there was already a mass cover-up by Chinese authorities in December 2019. Laboratories had already been ordered

to destroy samples. Physicians were forbidden to discuss it. Those who dared to talk about it were punished. Despite these facts, Tedros praised his communist benefactors in a statement on January 30, 2020. “In many ways, China is actually setting a new standard for outbreak response. It's not an exaggeration.”

These are astonishing words, considering the magnitude of Beijing's deception. But then, we are talking about a man who has a history of downplaying epidemics.

Compounding the early but fraught efforts to contain the virus, Tedros sided with China in calling on foreign nations to not restrict travel to and from the country. On February 3, 2020, Tedros said, “There is no reason for measures that unnecessarily interfere with international travel and trade. We call on all countries to implement decisions that are evidence-based and consistent.”

Meanwhile, the virus had already crossed the borders and gone global.

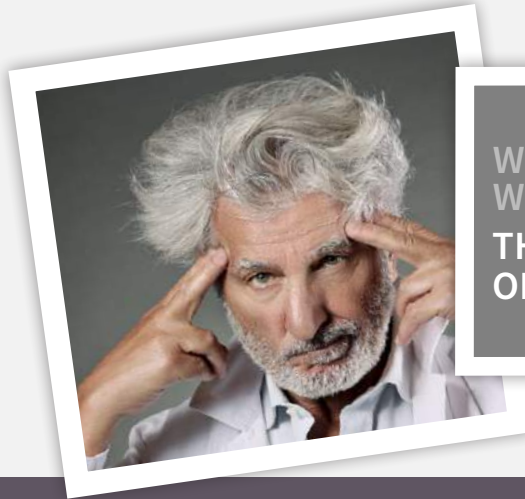
In every step along the way of this international fiasco, Tedros has kowtowed to the enemies of human rights. In January of this year, he stated that he was “disappointed” that China has not yet allowed in [over a year later] a team of researchers to delve into the true origins of the novel coronavirus. As Director-General of the WHO, he could and should demand more. But one does not bite the hand that feeds it.

All of this should give Christians pause and cause them grave concern. If such corruption is at the helm of an organization that exists ostensibly for “the attainment of all peoples of the highest possible level of health,” can it truly achieve that stated goal? Can it be trusted to have your best interest in mind, when the people running it obviously only have in mind their own interests?

Now that we know who is really running the WHO, the answer is clearly no. 📱
