CORRUPTION IS RAMPANT. FREEDOMS are abused. Information is twisted, and it is simply hard to know whom to believe anymore. The government is in confusion. Who is a hypocrite and whom can I trust? We've got to do something about this madness! Perhaps it's time to hold a rally.

But when we get to the rally, we seem to have another problem. Not everyone at the rally even agrees. We want to stand up against our oppressors. We want to show our support for humanity. But one person thinks the solution is not wearing masks, and another doesn't feel safe coming together without masks. One says Mr. Trump could have solved our woes had he become president. Another says Mr. Trump is racist and belligerent. Some support the police, while others hurl insults at them. A group of people storm the white house, and the whole assembly is labeled insurrectionist and brutal even though the majority probably did not agree with the violence. How are we to fight injustice with such a confused army?

One is reminded of the men who

assembled to David at the cave of Adullam to escape the oppression of Saul. Scripture tells us, "And every one that was in distress, and every one that was in debt, and every one that was discontented, gathered themselves unto him; and he became a captain over them: and there were with him about four hundred men" (1 Sam. 22:2). Hardly could there have assembled a more motley crew. "Everyone in distress" could have included almost anyone. We are not told what distressed these men. They were rough men, and no doubt men of opinion. They had gone

through a variety of life experiences and probably had a variety of responses. What was it that held them together? It doesn't seem like their good background or their congenial dispositions gave them

common ground. They had basically two things in common—debt and David. Whatever their struggles were, they had confidence in David. And it was in David they found their unity. They rallied around him and became an invincible band because they had a common leader. You cannot have a rally without a rallying point.

David was not the only man in history who successfully rallied an army in victory over their oppressors. One thinks of the people of Israel, enslaved and depopulated by a wicked Pharaoh. "And God heard their groaning, and God remembered his covenant with Abraham, with Isaac, and with Jacob. And God looked upon the children of Israel, and God had respect unto them. Now Moses kept the flock of Jethro his father in law... And the angel of the Lord appeared unto him in a flame of fire out of the midst of a bush." (Exo. 2:24-3:2). A groaning people, an embittered cry—here we find the same elements expressed in David's men. And what was God's first move? He prepared them a leader. It was Moses who faced

BIG PHARMA

WHAT BIG PHARMA WANTS, BIG PHARMA NEARLY ALWAYS GETS

WHILE VISITING A DYING FRIEND in the hospital years back, I was struck by a conversation among her attendant siblings (all seniors). In speaking of medications they had personally been prescribed, they laughed as they named the numerous side effects listed on the bottles: heart attacks, strokes—even DEATH, to name but a few.

Apparently, those seniors were willing to risk their very lives by taking toxic pharmaceuticals in the hope of gaining relief from some discomfort, despite the fact that the “cure” was potentially worse than the malady!

How did it become the gold standard in health care to have doctors prescribing drugs ridden with side effects?

Money Took Over Medicine

To understand this, we must look back to the late 19th and early 20th centuries, when a medical hijacking took place. The key figure was none other than the oil tycoon, John D. Rockefeller, who came to be America’s first billionaire.

Our lives today have been impacted by the discovery over a century ago that drugs could be produced with petroleum.

Not wanting to miss the money moment, Rockefeller seized both media and medical control, ousting the natural medicines used for thousands of years. After all, you cannot patent natural plants and herbs. It is reported that “after buying a German pharmaceutical company that manufactured chemicals of war for Adolf Hitler, Rockefeller leveraged his political influence to press congress to declare natural healing methods unscientific quackery.” Through massive grants, Rockefeller, along with the Carnegie Foundation, manipulated control of the medical schools and medical journals, removing diet and natural healing. Those who protested were deprived of their license to practice medicine. Others who dared to speak out were arrested and jailed!

Rockefeller took control of the *American Medical Association* (AMA). Needless to say, this had nothing to do with health, but everything to do with Rockefeller’s economic interests. “When evidence came out that his petroleum-based medicines caused cancer, he founded the Cancer Society, through which he suppressed that information.” But to a man with a ruthless drive for

riches, it mattered little that his products caused physical suffering and death for many. Cover up the lie and carry on. And to this day, the same pattern is repeated in this industry.

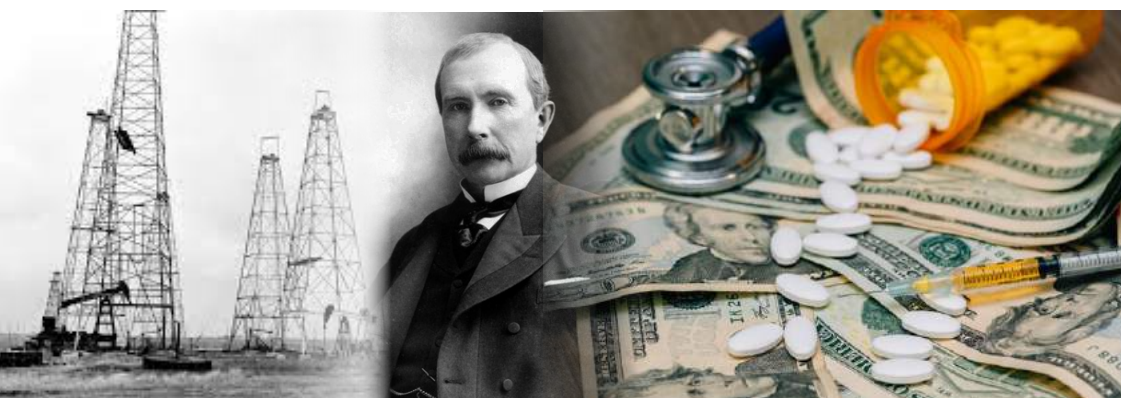
James Corbett, of the *Corbett Report*, stated “The crisis in today’s health care system is deeply rooted in the interwoven history of modern medicine and corporate capitalism. The major groups and forces that shaped the medical system sowed the seeds of the crisis we now face. The medical profession and other medical interest groups each tried to make medicine serve their own narrow economic and social interests.”¹

Pharma and Nazi Holocaust

The pharmaceutical industry cannot boast of an honourable history.

“In 1925, Bayer, [BASF and Hoechst] ...merged to form IG Farben, the world’s largest chemical and pharmaceutical company. The Allied Control Council seized IG Farben after World War II, because of its role in the Nazi war effort and involvement in the Holocaust, which included using slave labour from concentration camps and the purchase of humans for dangerous medical testing.”

“Fritz ter Meer, an IG Farben director and Nazi Party member who directed operations at the IG Farben plant at Auschwitz, was sentenced in 1948 to seven years for war crimes [slavery and mass murder] during the IG Farben Trial at Nuremberg. Released in 1950, he was elected chair of Bayer’s supervisory board in

1956 and remained in that position until 1964.”²

Karl Krauch, executive member of IG Farben, and the head of military economics for Hitler, was found guilty of mass murder, and served 6 years in prison. Then he became chairman of the board for BASF.

This is the same vaccine industry that protected and employed Nazi war criminals. The very industry that produced the Nazi gas chambers was purchased by Bayer.

“Chief Prosecutor Telford Taylor summarized the crimes committed by these corporate criminals with the following words:

Without I.G. Farben, the second World War would not have been possible.

Amazingly, the real culprits for the death of 60 Million people in World War II – the I.G. Farben executives – received the mildest verdicts. Even those executives directly responsible for the crimes in I.G. Auschwitz only received a maximum of twelve years in jail.³

The Nuremberg Trials codified laws against involuntary medical procedures. Currently, some governments are breaking this law, among others, by mandating vaccines in some schools, along with the current COVID protocols of masking,

lockdowns, health passports, etc. It is time to stand up for your rights, people!

Dispensing Poison

Interestingly, the word *pharmacy* is derived from the Greek *pharmakeia* and means, “use of drugs, medicines, potions, or spells; poisoning, witchcraft; remedy, cure,” from *pharmakeus* (fem. *pharmakis*) “preparer of drugs, poisoner, sorcerer” from *pharmakon* “drug, poison, philter, charm, spell, enchantment.” *Douglas Harper’s Etymology Dictionary*

These are fitting words for a medical system akin to sorcery, that has brought whole nations to its feet, paying them billions of dollars while receiving treatments often detrimental to health. Many doctors are as government-regulated drug pushers, having been trained to dispense poison.

Let me be clear, I do believe there are multitudes of health care professionals out there that sincerely seek the well-being of their patients, and I am thankful for their dedication. Many are but unwitting victims of the system, as are those who put their trust in it. Medical schools prepare doctors in the craft of pharmaceuticals, while neglecting the foundational importance of maintaining healthful diets, exercise, and the basic natural means to strengthen one’s immune system, along with other holistic practices.

Pills and injections are the order of the day, but are they the solution for the nation’s wellness, or the cause of the surmounting ill health of the populace? Does pharma-treating one’s symptoms cure the underlying cause of the sickness, or are the toxic substances exacerbating the problem and producing chronic sickness? One thing is very sure: Big Pharma’s profits keep soaring as it violently holds its grip on this medical cash-cow system.

I am not saying that there are no drugs that have been beneficial, but much of pharma’s offerings come

with detrimental, and sometimes deadly, side effects. Doctor-prescribed pharmaceuticals caused the death of my own mother.

The system, as a whole, is unquestionably based on profits, not health. There is a reason that medical error is now the third leading cause of death in the USA.

The Opioid Crises

In 2019, pharma giant Johnson & Johnson was criminally charged for its complicity in driving the opioid crises which, at that time, had taken over 400,000 lives.

On October 21, 2020, Purdue Pharma pleaded guilty to three federal criminal charges in regard to the opioid epidemic.⁴

The largest drug epidemic in American history is duly charged to big pharma, with a web of companies working in step to “influence doctors, researchers, federal regulators, and politicians.” They flooded the country with opioid pills, *targeting regions already hit the worst by the epidemic!*⁵

This callous disregard for human life for the sake of surging profits is shocking.

Such companies have been found to make false claims as to the safety of their products and to manipulate scientific papers.

These are not the only criminal charges J&J and Purdue have been found guilty of, nor are they the only pharma corporations that share a checkered history.

Reader, consider this: three of the major companies that are supplying COVID vaccines—AstraZeneca, Johnson & Johnson, and Pfizer—are felons. And Moderna has apparently never made vaccines before. With these companies

being free from liability in most places, it appears that Big Pharma is in its finest money-making hour. This begs the question—is the world population in for something far worse than the opioid epidemic?

Criminal Charges

“Big Pharma is also the biggest defrauder of the Federal Government under the False Claims Act, according to consumer watchdog group Public Citizen.”

“The industry has a history of fraud, bribery, lawsuits and scandals. Despite criminal charges and fines, Big Pharma companies continue to do business.”⁶

Despite paying out billions in fines, they just keep on going, crimes, cover-ups, settlements, and fines notwithstanding. What are billions to their deep pockets?

Robert Kennedy Jr. declared that “the four companies that make all 72 of our vaccines are four of the most corrupt companies in the world—Merck, GlaxoSmithKline, Pfizer, and Sanofi. Collectively, they are serial felons. They paid 35 billion dollars in the last ten years for falsifying science, defrauding regulators, lying to doctors, and selling drugs that they knew were poisonous and would kill people.”

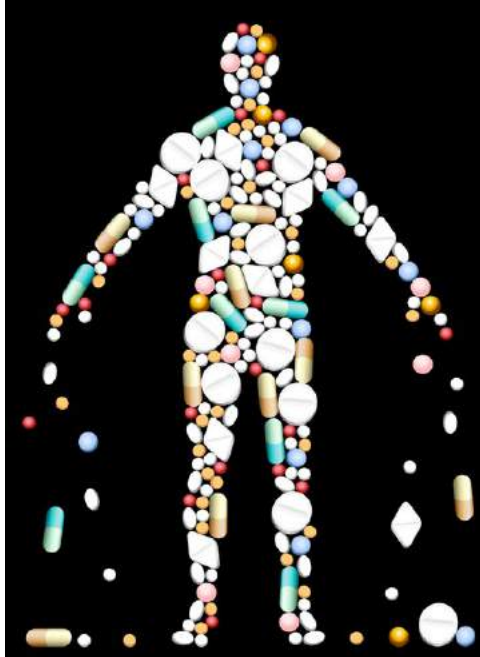
Frightening Amount of Power

It is said that no industry has more power over our lives than Big Pharma. They have the single largest lobbying power in Washington and spend twice as much as big oil to influence laws, policy, and public perception. That is a frightening amount of power!

Further, in the USA and New Zealand, pharmaceutical companies influence the media via millions of dollars in ads on television. These are the only two countries in the world that permit this. It has been said that mainstream media is Big Pharma’s mouthpiece.

Conflict of Interest

Dear readers, if you research

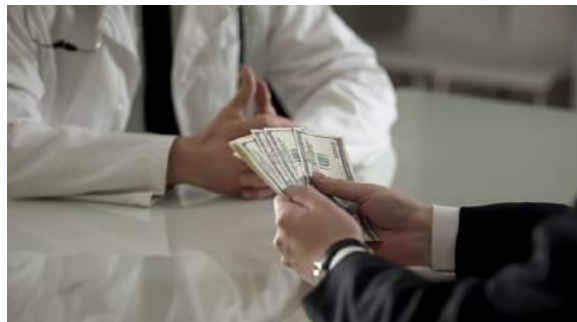
this subject, you will discover the murky world of the pharmaceutical industry. Dark money flows in its labyrinth of channels winding throughout corrupted institutes. From media to doctors’ offices to government officials and medical agencies, bribes, coercion, and greed drive this destructive monster along.

The system is seriously compromised as pharmaceutical companies have their tentacles wrapped around doctors, researchers, politicians, health institutes and regulators.

When the FDA is funded by the



pharmaceutical companies it is supposed to regulate, we have a serious conflict of interest. This industry is riddled with it.

It is said they contribute about two thirds of the FDA’s budget. But the FDA is not the only agency Big Pharma has captured with their big money. There are others, including the CDC, NIH, and WHO.

They also have an army of 1,378 paid lobbyists to spread its influence on Capitol Hill.⁷

Who owns Big Pharma? The better question is, who does Big Pharma own?

Corruption of Medical Journals

Medical journals have not escaped the corrupting hand of this dark industry. Richard Horton, editor of the *Lancet*, wrote in March 2004 that “Journals have devolved into information laundering operations for the pharmaceutical industry” Richard Smith declared that medical journals are an extension of the marketing arm of pharmaceutical companies. It has also been said that the industry has deflected the moral compasses of many physicians.

With between two-thirds and three-quarters of the clinical trials published in the major journals being funded by the industry, should we be surprised that the evidence for biased reporting is strong?⁸

Profits Surge While People Suffer

“The healthcare research company IMS Health projects worldwide sales of Pharma drugs to exceed one trillion dollars by 2014. With that kind of obscenely powerful money to throw around, what Big Pharma wants, Big Pharma nearly always gets.”

Global spending on medicines reached \$1.2 trillion in 2018 and is set to exceed \$1.5 trillion by 2023.⁹

Dr. Ben Tapper stated that “America is one of two countries that allow pharmaceutical ads on television. They make up 5% of the world’s population, yet they take in 65-70% of the world’s

pharmaceutical drugs. 80% of the people are suffering with a chronic disease associated with poor lifestyle choices: 700,000 will die with heart disease this year alone; 600,000 with cancer; 300,000 will die of obesity.”

Americans take in 70% of the world's pharmaceutical drugs and 80% of the people are suffering with chronic disease? Alarming truth! And people still trust their lives with this medical system?

Censorship

For some decades now, there has been a renewal of interest in holistic health in the Western world, bringing increased development to the wellness industry. People have been educating themselves about healthy diets, helpful supplements and seeking doctors of natural healing—the very things that Rockefeller worked to abolish in the early 1900s.

And, while Big Pharma—often referred to as a cartel or mafia—has been bullying its dissenters and whistle-blowers for over a century, there is presently a greatly accelerated trend to censor natural means of healing. It would seem that Big Tech and Big Pharma are best of friends in this endeavour. Internet searches for natural ways to prevent or cure cancer, for example, are more difficult to find, with those promoting such being deranked or banned from their media platforms.

In 1987, *The New York Times* reported that a US judge found the American Medical Association (AMA) guilty of conspiracy against chiropractors. It was shown that they attempted to:

- Undermine chiropractic schools.
- Undercut insurance programs for chiropractic patients.

- Conceal evidence of the effectiveness of chiropractic care.
- Subvert government inquiries into the effectiveness of chiropractic.
- Promote other activities that would control the monopoly that the AMA had on health care.

This judgment was upheld by the 7th United States Circuit Court of Appeals.

Why would the AMA knowingly conceal evidence of the effectiveness of chiropractic care? Are they alone in their corruption? Sadly, no.

And when it comes to COVID, some doctors working in pharma-regulated hospitals are not permitted to prescribe vitamin D and zinc, hydroxychloroquine, Ivermectin, etc., though these have apparently been proven cures. To speak out is to risk losing their positions.

The Federal Trade Commission (FTC) recently charged a St. Louis chiropractor for advertising zinc and vitamin D to combat COVID-19 and for questioning the safety of the COVID vaccine—which is not FDA approved.¹⁰

System Failure

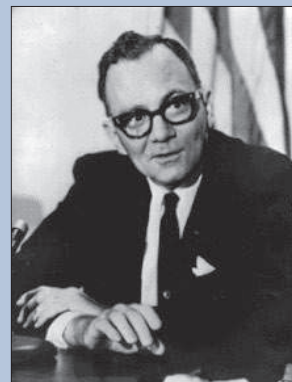
Dear readers, think not that the government's COVID narrative is about your health, any more than Big Pharma is operating in the interests of your health.

Vaccine makers are immune from liability

The only industry in the world that bears no liability for injuries or deaths resulting from their products are vaccine makers. The checkered past of vaccine companies

The four major companies who are making COVID vaccines are/have either:

- Never brought a vaccine to market

before COVID (Moderna and Johnson & Johnson).

- Are serial felons (Pfizer, and AstraZeneca).
- Are both (Johnson & Johnson).

Moderna had been trying to “Modernize our RNA” (thus the company name) for years, but had never successfully brought any product to market. How nice for the company to get a major cash infusion from the government to keep trying.

In fact, all major vaccine makers (save Moderna) have paid out tens of billions of dollars in damages for other products they brought to market when they knew those products would cause injuries and death—see Vioxx, Bextra, Celebrex, Thalidomide and opioids as a few examples.

If drug companies willfully choose to put harmful products on the market—when they can be sued—why would we trust any product where they have no liability?

Three of the four COVID vaccine makers have been sued for products they brought to market even though they knew injuries and deaths would result.

- **Johnson & Johnson** has lost major lawsuits in 1995, 1996, 2001, 2010, 2011, 2016, 2019 (For what it's worth, the company's vaccine also contains tissues from aborted fetal cells, perhaps a topic for another discussion).

- **Pfizer** has the distinction of the biggest criminal payout in history. The company lost so many lawsuits it's hard to count. You can check out its rap sheet here: <https://www.mp-22.com/vax>. Maybe that's why Pfizer is demanding that countries where they don't have liability protection put up collateral to cover vaccine-injury lawsuits.

- **AstraZeneca** has similarly lost so many lawsuits it's hard to count. Here's one. Here's another...you get the point. And in case you missed it, the company had its COVID vaccine suspended in at least 18 countries over concerns of blood clots, and it completely botched its meeting with the FDA with numbers from their study that didn't match.

- Oh, and apparently Johnson & Johnson (whose vaccine was granted Emergency Use Authorization in the U.S.) and AstraZeneca (whose vaccine is not approved in the U.S.), had a little mix up in their ingredients...in 15 million doses. Oops.

Given the free pass from liability, and the checkered past of these companies, why would we assume that all their vaccines are safe and made completely above board?

Where else in life would we trust

To me that makes as much sense as expecting a remorseless, abusive, unfaithful lover to become a different person because a judge said deep down they are a good person.

3 Ugly history of attempts to make coronavirus vaccines

There have been many attempts to make viral vaccines in the past that ended in utter failure—which is why we did not have a coronavirus vaccine in 2020.

In the 1960s, scientists attempted to make an RSV (respiratory syncytial virus) vaccine for infants. In that study, they skipped animal trials because the trials weren't required then. In the end, the vaccinated infants got much sicker than the unvaccinated infants when exposed to the virus in nature, with 80% of the

vaccinated infants requiring hospitalization. Two of them died.

After 2000, scientists made many attempts to create coronavirus vaccines. For the past 20 years, all ended in failure because the animals in the clinical trials got very sick and many died, just like the children in the 1960s.

- In 2004, attempted vaccine produced hepatitis in ferrets.
- In 2005, mice and civets became sick and more susceptible to coronaviruses after being vaccinated.
- In 2012, the ferrets became sick and died. And in this study, mice and ferrets developed lung disease.
- In 2016, this study also produced lung disease in mice.

The typical pattern in the studies referenced above is that the children and the animals produced beautiful antibody responses after being vaccinated. The manufacturers thought they

hit the jackpot. The problem came when the children and animals were exposed to the wild version of the virus. When that happened, an unexplained phenomenon called antibody dependent enhancement, also known as vaccine enhanced disease, occurred where the immune system produced a “cytokine storm” (i.e. overwhelmingly attacked the body) and the children/animals died.

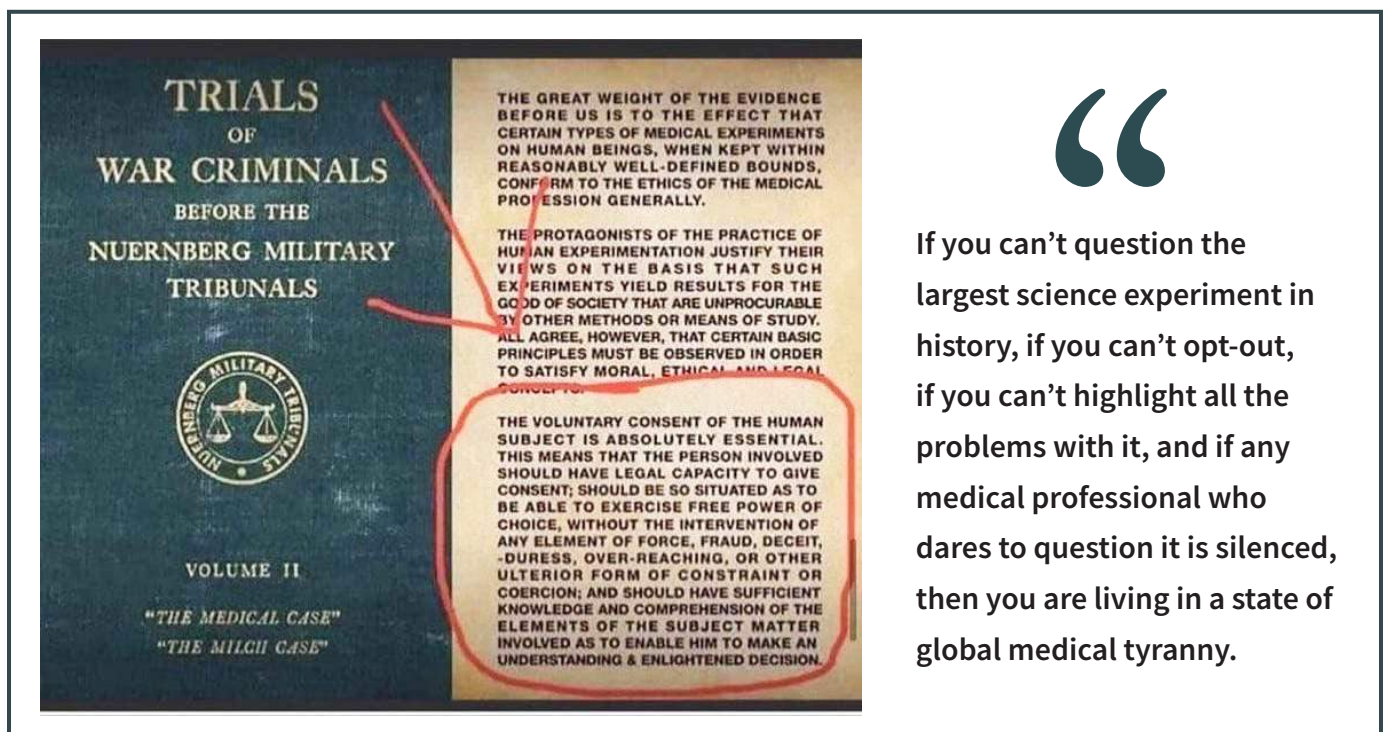
Here's the lingering issue: The vaccine makers have no data to suggest their rushed vaccines have overcome that problem.

Pharaoh for them and administered God's plagues of justice, embarrassing the gods of Egypt. It was Moses who brought them out of Egypt and guided them through the sea. It was Moses to whom, hungry and thirsty, they complained until his rod brought them water from a rock. It was Moses' uplifted hands which raised the standard that brought them victory in battle. And it was Moses, when the people were plagued by fiery serpents, who held up a serpent on a pole to which they could lift their eyes and find relief.

Years later, Nicodemus knew and loved Moses but was disillusioned by the hypocrisy of those who claimed to represent him. Pointing back to Moses, Jesus drew a line to Himself, showing Nicodemus that there was a living standard bearer in his day. "As Moses lifted up the serpent in the wilderness," Jesus declared, "even so must the Son of man be lifted up: That whosoever believeth in him should not perish, but have eternal life. For God so loved the world, that he gave his only begotten Son, that whosoever believeth in him should not perish, but have everlasting life: (John 3:14-16). God so loved the world, that He gave them a rallying point—a point of belief through whom they could be linked to heaven. Whosoever believed on God's given standard bearer could be saved.

The world is now engulfed in turmoil unlike any we have heretofore known. The silencing of the gospel message for a time has produced a division and unbelief perhaps never equalled in other ages. There has been no shepherd worth

trusting, and the flock of humanity is scattered to its own devices, easy prey to every wolf, political or otherwise. No restoration, no gathering of the flock, is possible until there be a restoration of true leaders. Our salvation—like the salvation of Nicodemus and the salvation of the people pursued by fiery serpents—must come by turning our eyes toward that rallying standard whom God will provide.

People are sometimes disparaged for being sheep—the fact is we cannot entirely avoid being sheep. There is danger in being a sheep if you blindly follow a wolf. There is no danger in a sheep following a true shepherd. As Moses lifted up a standard in the wilderness, and as the uplifted Christ has rallied men through time, God has assured us that He will not leave us without a place to lift our eyes in the day of trouble. "When the enemy shall come in like a flood," He promised, "the Spirit of the Lord shall lift up a standard against him" (Isaiah 59:19). For us too then, there is a rallying standard—and where there is a standard lifted, there is always a standard bearer. As flies rally to a light source, so the honest in heart will rally to truth. And prophecy tells us from where that truth will come: "Out of Zion, the perfection of

beauty, God hath shined" (Psalm 50:2).

Together we stand. But how shall we stand together without a common belief to stand on; and how shall we believe without a preacher? All the political platforms we know have failed us. They are part of the broken system, and they themselves are silencing men who speak the truth. We need a different platform than republican or democrat, conservative, liberal, or independent. We need a prophet. We need a standard bearer who can define and hold up the truth for the entire world in a followable, trustworthy way. Before God could bring the Israelites up from Egypt, He took the time to train Moses. And again, at this junction of crises, He has prepared true leaders after His own heart to whom the people can turn and find deliverance. 📖

We need a baptism of clear seeing. We desperately need seers who can see through the mist – Christian leaders with prophetic vision. Unless they come soon it will be too late for this generation. 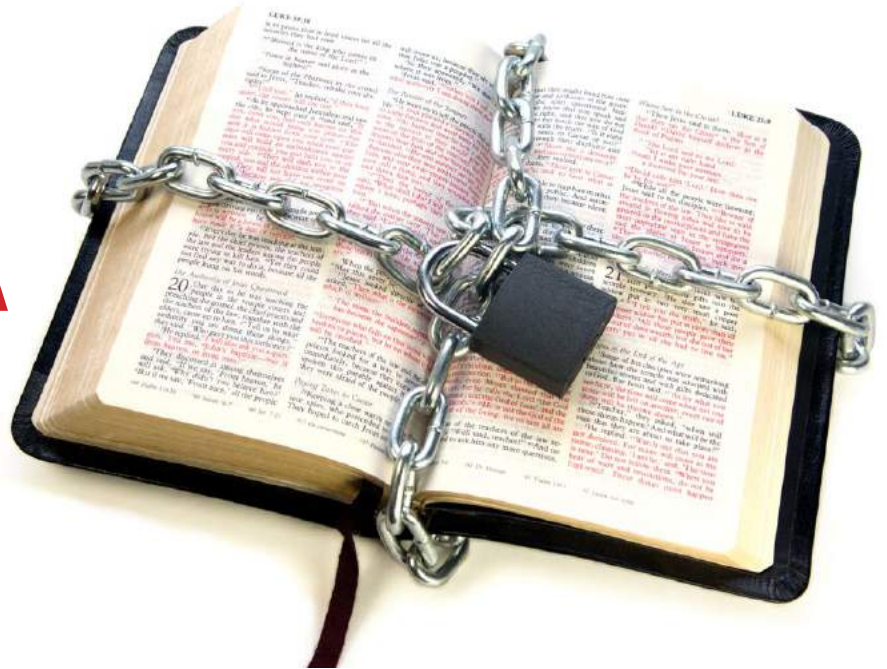

CANADA

LAND OF THE OPPRESSED

In 2015, a report from the *Legatum Institute* deemed Canada the freest country in the entire world. For centuries, Canada was a beacon of light to the oppressed and persecuted in other nations. Who could have foreseen the obscuring of that light! Under the blanket of COVID, Canadians are seeing a dismal abrogation of their constitutional rights.

In the past thirteen months, the freedoms historically upheld in Canada have steadily and quickly become null and void as the Emergency Act invoked in response to COVID has taken precedence over all else. Under this Act, the government is empowered to do just about anything it thinks necessary to cope with the “crisis.” Churches in particular have felt the sting of such unchecked powers.

Earlier this February, Pastor James Coates of GraceLife Church in Edmonton, Alberta, was arrested after failing to comply to the Public Health Act and continuing to preach to his assembled congregants. After spending a month in a maximum security prison, all but one of the charges against him were dropped and he was released from custody without conditions. But far from restoring the freedoms of religious convictions, the authorities proceeded by barricading the church building with three layers of

fencing and stationing guards to secure the site 24/7. Since then, his congregation has been meeting in secret.

In Calgary, Alberta, Pastor Artur Pawlowski has gained international attention for defending himself from unlawful interruptions to his church services by health officials and police officers who have repeatedly acted in contradiction to Section 176 of the Criminal Code, which plainly states “every one who willfully disturbs or interrupts the assemblage of persons met for religious worship...is guilty of an offence punishable on summary conviction.” After being sent away shamefacedly more than once, the authorities have finally gained consent by the Court “to do anything necessary” to enter Pawlowski’s church and arrest him if “reasonable grounds” are found.

Our own congregation in Aylmer, Ontario, has continued to face persecution under the guise of the COVID pandemic. For over a year, officials have attempted to stop Pastor Henry Hildebrandt and his congregation from exercising their religious rights to worship together. In a desperate attempt to shut down the church, authorities sought the court to lock up the church building and impose steep fines on the church. Thankfully, on April 30th, the judge refused their request

for now, deferring the decision to a later court hearing. But on this same day, only an hour away, Trinity Bible Chapel did not fare so well. A judge granted an injunction to lock the church’s doors, at least temporarily.

Believers forced to meet in secret, pastors sent to prison, church doors barred by authorities...were we to read of such in far away nations, we would shudder at the thought of such oppression and tyranny!

Lawyer John Carpay stated, “This is likely the first time in Canadian history that a federal or provincial government has directly restricted religious freedom. Unscientific and arbitrary health orders have been imposed by an unelected and politically appointed doctor, whose orders are not scrutinized by elected members of the Legislative Assembly.”

Some Canadians have perhaps been blindsided by such unprecedented actions, but those like Artur Pawlowski, who sought refuge in Canada after living under oppressive governments, sees the warning signs of tyranny clearly.

Oh, Canada! Will those that have fled to you for refuge be forced to witness the resurgence of the oppressions they had once escaped? If there was ever a time to stand on guard for Canada, and pray to God to keep our land glorious and free, it is now! 🇨🇦
